

SHAKOPEE PUBLIC SCHOOLS SCHOOL AGE CHILD CARE



Shakopee elementary schools will transition to Distance Learning beginning on November 23, 2020. Care will be available for parents starting on November 18, 2020. Shakopee Public Schools, in partnership with River Valley YMCA, will provide high quality care to students grades K-5. Care will be available to all families enrolled in both Shakopee IHD and Shakopee Online programs 5 days a week.



CENTRAL FAMILY CENTER MONDAY-FRIDAY 6:15 A.M. TO 6:15 P.M.

The River Valley YMCA will provide care for students in grades K-5 at Central Family Center (505 Holmes Street South). Children and families can enter through door D.

Students should bring their own water bottles and snacks. A free district breakfast and lunch will also be provided.

Students will be able to participate in distance learning and should bring devices, chargers and any other supplies they need to participate.

Masks are required. Social distancing, hand washing, and all other department of health guidance will be followed.



RATES

Rates are based on one-full day of care and for each child that rate is \$40.

There are special discounts for Shakopee Public Schools staff members, as well as free care, for Tier 1 Essential Employees.

If you are currently enrolled and need to update your schedule, reach out the YMCA directly.

If you are a Tier 1 Essential Employee, you must sign up for the YMCA before receiving Tier 1 discount application. During registration, you may be asked to enter credit card information or pay an enrollment fee. These fees will be reimbursed/waived once this application is filled out and your family meets the requirements of free Tier 1 care.



TIER 1 ESSENTIAL EMPLOYEES - NON-DISTRICT STAFF

Free child care for children of our essential workers is being offered for the 2020-21 school year. If you believe you are a Tier 1 (essential worker), please let the YMCA know after you have registered. According to Governor Walz's Executive Order 20-94, all of the parents or legal guardians in the child's household must be workers in Tier 1 industries to receive discounted care.

Tier 1 employees include:

- Healthcare and public health
- Law enforcement, public safety and first responders
- Food and agriculture
- Judicial Branch (essential services)
- National Guard (activated under a Governor Executive Order)
- Educators in pre-K through grade 12 settings
- School staff caring for children of critical workers
- Child care and school-age care providers
