

Member Peterson introduced the following resolution and called for its adoption:

**RESOLUTION CANVASSING RETURNS OF VOTES
OF SCHOOL DISTRICT ELECTION**

BE IT RESOLVED by the School Board of Independent School District No. 720, Shakopee Public Schools, State of Minnesota as follows:

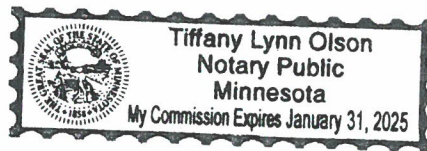
1. It is hereby found, determined, and declared that the election of the voters of the district held on November 2, 2021, was in all respects duly and legally called and held.
2. As specified in the attached Abstract and Return of Votes Cast, at said election a total of 7,634 voters of the district voted on School District Ballot Question One, relating to the approval of School District referendum revenue authorization, of which 5,060 voted in favor, 2,566 voted against same, and there were 8 completely blank or defective ballots relating to this question.
3. Said proposition, having received the approval of at least a majority of such votes, is hereby declared to have carried.
4. As specified in the attached Abstract and Return of Votes Cast, at said election a total of 7,634 voters of the district voted on School District Ballot Question Two, relating to the additional School District referendum revenue authorization, of which 4,774 voted in favor, 2,836 voted against same, and there were 24 completely blank or defective ballots relating to this question.
5. Said proposition, having received the approval of at least a majority of such votes, is hereby declared to have carried.
6. The School District clerk is hereby directed to certify the results of the election to the county auditors of each county in which the School District is located in whole or in part. The clerk is also directed to report the results of the election to the Commissioner of Education within fifteen (15) days of the date hereof.

The motion for the adoption of the foregoing resolution was duly seconded by Tomeczik. On a roll call vote, the following voted in favor:

whereupon said resolution was declared duly passed and adopted.
